PROVISION C. (SPECIAL PROVISIONS)

1. Check heights of structures prior to move to ensure adequate clearance.
2. Specifically check overhead structures located _____.
3. While crossing non-interstate structures, slow to 10 m.p.h.; keep all other traffic off; and use centerline of bridge on: (a) Bridges located _____, (b) All bridges.
4. To ensure the safety of other traffic: (a) One escort shall be provided. (b) Two escort vehicles shall be provided, a height pole shall be mounted on the lead vehicle. (c) _____ escort vehicles shall be provided. (d) One escort vehicle equipped with a height pole set three inches above permitted load height shall precede the load.
5. Booms on cranes and similar construction equipment shall be adequately secured to prevent movement while in transit.
6. While crossing all interstate highway structures, hold minimum speed and maintain a 300 ft. interval.
7. The permittee assumes sole responsibility for all damages to any overhead utility facility as a result of this movement.
8. The maximum speed, except on highways with a minimum posted speed, in which case the speed shall not be more than 5 m.p.h. above the minimum posting shall be _____ m.p.h.
9. Movement of objects greater than 14 feet 6 inches wide and up to and including 16 feet wide are limited to the hours of 9:00 a.m. to 3:00 p.m., Monday through Friday, in the following counties: Cook, Dupage, Lake, Kane, Madison, McHenry, Monroe, St. Clair and Will. In all other counties, movement is allowed from one half hour before sunrise until one half hour after sunset Monday through Friday, and from one half hour before sunrise until noon on Saturday. Movement of objects greater than 16 feet wide are restricted to the hours of 9:00 a.m. to 3:00 p.m. Monday through Friday statewide.
10. Shoulders: Move shall be made only when shoulders of the pavement are dry and firm. _____
11. An Illinois State Police escort shall be required. Notify Illinois State Police headquarters at _____ at least 24 hours prior to move.
12. The permittee shall notify the District _____ Highway Engineer 24 hours prior to the movement. Written permission must be secured from the District Highway Engineer to trim trees, remove signs and traffic signals, or to perform other acts in preparation for making the movement.

SPECIAL VEHICLE MOVEMENT PERMIT PROVISIONS

PROVISIONS A. GENERAL PROVISIONS

READ YOUR PERMIT BEFORE STARTING MOVE. If you find the permit does not cover the move, is incorrect or in error, contact the Department prior to starting the move. Undertaking the move is prima facie evidence of acceptance of the permit.

Only the original permit transmittals are valid; copies have no legal status.

THIS FORM PART OF PERMIT: When specified, the conditions and restrictions listed in this form govern the movement of vehicles or objects authorized by written permit issued by the Department under Section 15-301, of The Illinois Vehicle Code. The conditions and restrictions specified are a part of the permit as though written in detail in the transmittal.

CONDITIONS THAT APPLY: The conditions and restrictions that apply will be specified by code letter and number and identified as BT 993 Provisions, **Form Bt 993 must be carried in the vehicle to which the permit applies.** Copies of Form BT 993 are available from the Department.

PRECEDENCE: In case of conflict, the precedence shall be (1) conditions stated in detail in the short form permit, (2) those stated under Provision "C", (3) those stated under Provisions "B", and (4) those stated under Provision "A".

PERMIT TO ACCOMPANY MOVEMENT: The driver of the vehicle shall have the permit in his possession during the progress of the movement and shall show said permit, on demand, to any police officer or authorized employee of the Department. The permit covers only the person or firm designated as grantee and is not transferable.

ABBREVIATED TERMS: The following abbreviations are authorized for use in these permits. Be sure you know the meaning of the abbreviations found in your permit before beginning your move.

AGREEMENT: The acceptance of the permit by the grantee constitutes an agreement that the movement will be made strictly in compliance with the terms set forth in the permit and the applicable provisions of the Department Policy contained in the current issue of the publication "OVERSIZE AND OVERWEIGHT PERMIT MOVEMENTS ON STATE HIGHWAYS."

JURISDICTION: The permit is effective only insofar as the Department has jurisdiction and does not release the grantee from complying with other existing laws that may apply to the movement.

OVERWEIGHT MOVEMENTS: An overweight permit authorizes the movement of a vehicle or a reasonably disassembled single object loaded on a vehicle combination. If stated in the permit, the object may include an attachment; however, it must be securely mounted on the object being moved. The attachment may not be hauled as a separate object on the vehicle combination.

GENERAL PROVISIONS A (continued)

LOCATIONS WHERE PERMIT IS NOT VALID. The permit is not valid on any highway or bridge posted for a load limit less than the gross weight of the move, on any highway closed to traffic, and on any highway not maintained by the Department of Transportation. The right to use highways other than those specified is neither implied nor granted. The permittee must obtain permission from the proper local authority to use local streets or highways or from the Illinois State Toll Highway Authority if over the Tollway.

RESTRICTIONS ON MOVEMENTS: All movements made under authority of permits not specifying routes shall exercise due caution to prevent unauthorized use of any structure, highway, temporary route detour, turnaround or turnaround. Posted maximum width, height, speed, gross weight or other restrictions shall be observed.

AUTHORIZED TIMES OF MOVEMENT: Movements are authorized from one half hour before sunrise to one half hour after sunset Monday through Friday, and from one half hour before sunrise until noon, Saturday. Movements are further restricted on specified holidays, beginning at noon the day preceding the holiday or the holiday weekend. The specified holidays are: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. Overweight permit loads with legal dimensions are allowed 24 hour a day, 7 day a week movement.

HIGHWAY CONDITIONS: Move shall not be made when highway is covered with snow or ice.

INCLEMENT WEATHER: When visibility is unduly impaired by rain, snow, fog, smog or at any time travel conditions are considered to be unsafe by the Department or State Police, the police may direct or escort a vehicle off the roadway to a place of safety.

RIGHT-OF-WAY DURING MOVEMENT: Insofar as practicable, movements shall be confined to a single traffic lane and shall be made in such a manner that the rest of the roadway will be open at all times so the flow of other traffic will not unnecessarily be obstructed. Also, insofar as practicable, other traffic will be given the right-of-way over this movement. The driver shall remove the vehicle from the roadway when necessary to allow an accumulation of traffic to pass or when so directed by a police officer.

SPEED: Maximum speed shall be 45 m.p.h. on all permit movements or 5 m.p.h. above the minimum posted speed limit, EXCEPT when otherwise specified in the permit. Legal weight, legal height movements up to and including 10 feet wide are allowed to travel at the legal maximum speed limit.

LEGAL HEIGHT MOVEMENTS: Permit authority is not required for the movement of vehicle(s), inclusive of load, not exceeding the legal height limitation of 13 feet 6 inches as established in Chapter 15, The Illinois Vehicle Code. Therefore, no action is taken by the Department, either separately or in conjunction with authorizing an otherwise oversize or overweight movement, to ensure adequate clearance of structures for a vehicle(s), inclusive of load, not exceeding 13 feet 6 inches overall height.

PUBLIC AND PRIVATE LIABILITY: The grantee assumes all responsibility for injury to persons or damage to public or private property, including his own, caused directly or indirectly by the transportation of vehicles or vehicles and objects authorized under this permit. The grantee agrees to hold the State of Illinois harmless from all suits, claims, damages or proceedings of any kind and to indemnify the State of Illinois for any claim it may be required to pay arising from the movement.

LIABILITY INSURANCE: Owners and/or operators of escort vehicles or vehicles with oversize loads exceeding 10 feet in width, 13 feet 6 inches in height, 110 feet in length or overweight must have in effect or be self-insured in the minimum amount of \$500,000 per occurrence combined bodily injury and property damage.

GENERAL PROVISION B. OVERDIMENSION

RED FLAGS: The extremities of all oversize vehicles, vehicle combinations or loads, and all protruding objects shall be marked with clean red flags not less than 18 inches square.

ESCORT VEHICLES: One escort vehicle will be required on all loads more than 14 feet 6 inches wide. A pole for measuring vertical clearances shall be mounted on the lead escort vehicle for moves in excess of 14 feet 6 inches in height. An escort vehicle may be a passenger car, or a second division vehicle not exceeding a gross vehicle weight of 8000 pounds that is designed to afford clear and unobstructed vision both front and rear. Escort vehicles shall display red flags at the extremities, display "OVER SIZE LOAD" signs, be equipped with an operating rotating or flashing amber light mounted on top, and be operated by properly licensed operators at least 18 years of age. The driver of the escort vehicle must be in radio contact with the driver of the permit vehicle.

OVERLENGTH OBJECTS: Movements of objects over 80 feet in length shall be equipped with two operating flashing amber lights -- one over the cab of the vehicle; the other within 10 feet of the rear of the object, mounted as high as practicable over it.

RESTRICTIONS IN COOK COUNTY: a. Movements exceeding 10 feet in width, 13 feet 6 inches in height, and 88,000 pounds gross weight are prohibited on the expressways in Cook County, except Interstate Route 80 west of Kedzie Avenue, Interstate Route 57 from U.S. Route 6 (159th Street) south, Interstate Route 290 north of St. Charles Road and Illinois Route 53.

b. Within the area bounded by 95th Street, Illinois Route 50 (Cicero Avenue), Illinois Route 38 (Roosevelt Road), Central Avenue, Touhy Avenue and Lake Michigan that is in the City of Chicago, and on expressways in Cook County north of Interstate Route 80 and east of Illinois Route 83, permit movements not exceeding 10 feet in width are authorized between the hours of 9:30 a.m. and 3:00 p.m. (until noon on Saturday). Movements exceeding 10 feet but less than 12 feet in width are authorized only between the hours of 7:00 p.m. and 6:00 a.m. Movements exceeding 10 feet in width and having an origin or destination within this area may travel during hours of darkness in Cook County for a distance of up to 10 miles outside the nearest boundary of this area.

c. Movements over 12 feet in width within Cook County that are not subject to the restrictions in paragraph (b) are authorized only between the hours of 9:30 a.m. and 3:00 p.m. (until noon on Saturday).

d. Contact should be made with the City of Chicago (312/744-4696) regarding permit requirements for movements on all streets and highways within the city other than the expressways.

STATE LINE BRIDGE RESTRICTIONS: Movements exceeding 9 feet in width are prohibited on the Interstate Route 55 and 70 Mississippi River bridge. Movements exceeding 10 feet 4 inches in width are prohibited on the U.S. Route 60 and 62 and the U.S. Route 67 Mississippi River bridges into Missouri. The maximum width allowed on the U.S. Route 34 Mississippi River bridge into Iowa is 10 feet.

HOUSE TRAILERS: The overall width of the house trailer includes doorknobs, awnings or any other attachments. The towing unit of house trailers over 8 feet but not more than 10 feet wide shall be at least a 3/4-ton truck. The towing vehicle of a house trailer over 10 feet but not more than 12 feet wide shall be at least a 1-ton truck with dual wheels. The towing vehicle of a house trailer over 12 feet but not more than 14 feet wide shall be at least a 2-ton truck with dual wheels. Movement of house trailers over 12 feet wide is prohibited when wind gusts exceed 25 m.p.h.
